The qualitative experience: living with a sibling with anorexia nervosa

This information sheet is for you to keep.

My name is Samantha Ferguson and I am conducting a research project with Dr Gordon Walker, a Professor in the School of Psychology, Psychiatry and Psychological Medicine, towards a Postgraduate Diploma in Psychology at Monash University. The research project involves conducting a project that will result in the writing of a thesis for possible submission to a scientific journal for publication.

The Eating Disorders Foundation of Victoria has allowed me to make the conduct of this study known to their clients and their clients' families, and is supportive of the research being undertaken.

The aim of this study is to find out about the lived experiences of young people who have a sibling with anorexia nervosa. Very little research has ever been done in this area, and it is considered important to understand what it is like to live with a sibling that is suffering from this illness.

By participating in this research, you will be helping to build an understanding of the way in which living with a sibling with an eating disorder might affect young people's lives, their relationships within their families, and of what services might help young people who experience this in the future. It will also give you a chance to talk about your experiences and your feelings.

The study involves an informal interview with the researcher. This discussion will take approximately one hour and will be largely semi-structured, so it will be dictated by your experiences. The location of this interview will be decided by you and the researcher.

It is possible that when talking about your feelings and experiences you may feel a bit uncomfortable or anxious. This would be entirely normal. If you feel very anxious the interview can be stopped, and information about support lines or support groups that you can make use of will be provided.

Participating in this study is voluntary and you are under no obligation to consent to being involved. If you do consent to participate, you may withdraw from the study at any time.

The information you provide will remain completely confidential; the only people who will have access to the information will be Samantha Ferguson and Dr Gordon Walker. Storage of the data collected will adhere to the University regulations. Interview documents and audio tapes will therefore be stored in a locked filing cabinet in a locked office at Monash University, and electronic information will be stored on a password protected computer.

The identifying features of the interview transcript will be stripped within 4 months of collection and tapes will be erased. Study data must be kept for a minimum of five years after the conduct of the research, however after this time all information will be disposed of in a confidential manner.

The final thesis may include short extracts of interview transcripts, but these will be reported in such a way as to make them unidentifiable. In these cases pseudonyms will be used to protect confidentiality.
